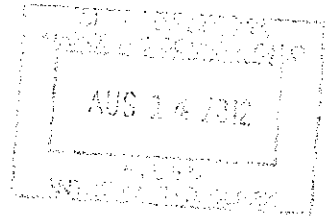

This matter came before the Court on motion of the Defendants Steve Liller, General Manager of Alpha Security LLC and Alpha Security LLC by and through counsel, for a default judgment pursuant to Rule 55 (A) of the Ohio Rules for Civil Procedure.

The Court finds that Plaintiff Melvin Marinkovic was duly served with process in accordance with Rule 4 of the Ohio Rules of Civil Procedure by certified mail, return receipt requested on May 18, 2012. That the Plaintiff was granted a leave to move or plead on or before July 15, 2012. To date Plaintiff has failed to move, plead or otherwise defend as provided by the Ohio Rules of Civil Procedure.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Motion for Default Judgment filed by Defendants Steve Liller, General Manager of Alpha Security LLC and Alpha Security LLC is sustained and judgment is hereby granted in favor of Defendants Steve Liller, General Manager of Alpha Security LLC and Alpha Security LLC and against Plaintiff Melvin Marinkovic as follows:

1) Pursuant to Ohio Revised Code Section 2323.52(D)(1) Plaintiff Melvin Marinkovic aka Mel Marin, Mel. M. Marin, Melvin M. Marin, Mel M. Marinkovic, and Milivoj Marinkovic is hereby declared to be a Vexatious Litigant; and

2) That the Plaintiff Melvin Marinkovic prior to the institution of legal proceedings in the Court of Claims in the State of Ohio or in the court of common pleas, municipal court or county court in Mahoning County shall first obtain leave of that court to proceed; and

3) That the Plaintiff Melvin Marinkovic is prohibited from continuing any legal proceedings that the Plaintiff Melvin Marinkovic had instituted in the Court of Claims in the State of Ohio or in the court of common pleas, municipal court or county court in Mahoning County prior to the entry of the order; and

4) That the Plaintiff Melvin Marinkovic is prohibited from making any application, other than an application for leave to proceed under ORC Section 2323.52(F)(1), in any legal proceedings instituted by the Plaintiff Melvin Marinkovic in the Court of Claims in the State of Ohio or in court of common pleas, municipal court or county court in Mahoning County.

IT IS SO ORDERED.
